

 - (b) are perpetual and it is understood that I / we will not receive any payment, royalty or



other consideration (whether monetary or otherwise) from the Centre in connection with the making, use or storage of the Images and Recordings;

- 3. The Centre collecting, storing, handling, accessing, managing, transferring, using and disclosing Images and Recordings of me / us and the Children, including but not limited to my / our first name only (no surname), our membership of the Centre and the location in which the Images and Recordings were taken, in connection with the Promotional Materials;
- 4. Any Promotional Materials which refer to me / us and the Children, expressly or by implication, are, at the date of publication, made in good faith and are not intended to defame or offend me / us or the Children or bring me / us or the Children into disrepute;
- 5. The Centre is the owner of the copyright in the Images and Recordings and the physical Images and Recordings, although I / we may request a copy of the Images and Recordings at any time;
- 6. I / we may, at any time, request the Centre in writing to remove any Images and Recordings of the Children and / or me / us from any Promotional Materials under the control of the Centre; and
